The Haliburton Broadcasting Group, its subsidiaries and affiliated companies (Moose FM & FM105.5), will conduct the contest substantially as described in these rules, and by participating, each participant agrees as follows:

1. Description of Contest/Participation.

A. Dates of Contest: The contest will begin on October 31st 2011, and end on or about November 27th, 2011.

B. How to Play: Visit our website at moosefm.com and click on the Muskokalicious-4 button to print off your ballot or, you can visit any of the listed participating restaurants to fill out a ballot. Participants may enter a maximum of once per day, at any, and all participating locations. Each location will collect ballots. All restaurants will do their own on-site draw after Nov27th, 2011 for their own special offer and will contact their winners directly. All ballots from each location will then be collected and the Moose and FM 105.5 will select the winning ballots for each of the four grand prize getaways. Draws will be made live on-air no later than December 9th, 2011.

2. Prize(s). The prize(s) that will be awarded in each restaurant location as well as all 4 grand prize winners:

A certificate will be provided to the selected winner signed by an officer of the participating restaurant sponsor confirming the prize that the winner will receive. Details and disclaimers will also be included with the winner's certificate along with restrictions or limitations if applicable. You must provide photo id to claim your prize.

3. Eligibility and Limitations.
